## Nea Resolution for 2021-2022

Annalisa Moore shared a presentation to reopen schools 5 days a week safely. COVID cases have been dropping. Several months have passed and we have provided safe school environments. We believe the full day is the best practice for our learners. Research and Understanding for the decision to have school open 5 days a week. Masks will be worn, contact tracing will be followed, cleaning procedures will be followed, Crisis Manager will have added duties to report school information to the county. Adult vaccinations are increasing, lowering the risk. Age 12-17 students are able to get the vaccine. Summer planning is in the planning process. Fall schedule will be in person, outreach to the community to encourage families to come back. Nea Intersession extended hours and office hours after school also provide. Planning for the future: classrooms with 3 feet space between all the children. CDC sees the physical distancing will shift. Remote learning K-5 and 6-12 will be offered to learners that have health risks and or live with a family member that is at risk. Reading intervention and Math intervention and mitigation to help support the students. Nea aligns with CDC requirements.

Comments: Ms. Crawford was surprised not to see the facilitators not mentioned in this resolution. Our community is made up of our staff, facilitator, learners, and families . Facilitators/Staff needs to be added to the resolution. We need to make sure the staff is supported. Otherwise it does not feel right. Annalissa added that wording. Annalisa has spoken to Nau and will apologise for not adding that wording.

Leila Richards appreciates that there is a plan if we have to go back to a hybrid schedule.
